 - (b) In accordance with subrule 8(ii)(f)(1) I considered it advisable to submit the proposed rule alterations to members of the BOM via email having determined it inconvenient to call the BOM together.
 - (c) On 16 September 2025 I submitted a copy of the report by the Rules Committee, along with specific details of the proposed rule alterations (included as appendix A) and a resolution to members of the BOM via email.
 - (d) I requested that they cast a vote for or against this resolution via return email to me by 18 September 2025 in accordance with subrule 8(ii)(f)(2).
 - (e) As per the quorum requirements set out in subrule 8(ii)(b) 'more than half of the members of the BOM shall form a quorum'. There are currently 24 members of the BOM.
 - (f) By 17 September 2025, all 24 members of the BOM had returned their vote to me via email. As such the quorum requirements set out in subrule 8(ii)(b) were met. The members of the BOM unanimously adopted the resolution.
 - (g) I have requested that in accordance with subrule 8(f)(3), this resolution shall be recorded in the minutes of the next BOM Meeting.

- (h) I have requested that the Northern Mining and NSW Energy District Branch post on its website a notice about the proposed rule alterations.
- 4. I declare that the particulars set out in this notice are true and correct to the best of my knowledge and belief.
