NOTICE OF PARTICULARS OF AUTHORISATION AND DECLARATION OF AUTHORISED OFFICER

official, give notice of the following matters in relation to the rules of the Mining and Energy

Union, Northern Mining and NSW Energy District Branch.

1. I am the District Secretary of the Northern Mining and NSW Energy District Branch of

the Mining and Energy Union.

2. The Mining and Energy Union ("the MEU") is an organisation of employees registered

under the Fair Work (Registered) Organisations) Act 2009.

3. I am authorised to give this notice of particulars of alterations to the rules of the

Northern Mining and NSW Energy District Branch of the MEU and to make this

declaration as required by regulation 126 of the Fair Work (Registered Organisations)

Regulations 2009.

4. The Northern Mining and NSW Energy District Branch of the MEU has sought to alter

its Rules to allow for the introduction of a District Vice-President (E), at the discretion

of the Board of Management, whenever membership and operational needs require.

Particulars of the alterations the subject of this notification are annexed to this

declaration and marked **Annexure 'A'**. An explanation of each change is as below;

(a) Rule 8(1) of the Rules provides that the Committee of Management of the District

Branch shall be the Board of Management. The Board of Management shall be

composed of the District Executive Officers, the District Central Councillors, such

number of Mining Lodge representatives and Energy member representatives

that shall be determined from time to time by the Board of Management and one

(1) female affirmative action representative.

- (b) Rule 8(ii)(c) currently provides that the District President, District Vice-President (A), District Vice-President (B), District Vice-President (C), District Vice-President (D), District Secretary, District Central Councillors, including the Female Central Councillor, District Check Inspector (A), District Check Inspector (B).... shall have a deliberative vote at any meeting of the Board of Management. The proposed change to Rule 8(ii)(c) includes an additional District Vice-President (E).
- (c) The proposed rule change includes the addition of Rule 8(k), which would allow the Board of Management to determine, from time to time, if the office of District Vice-President (E) is required for the effective operation of the District Branch. If it is determined that the position is required then it will be filled by way of an election in accordance with Rule 17 of the MEU Rules.
- (d) The proposed rule change includes the addition of Rule 10(b), which allows for the position of District Vice-President (E) to be a member of the Board of Management and to have a deliberative vote at any meeting of the Board.
 - (e) The proposed rule change includes a reference to District Vice-President (E) in Rule 10(ii)(b).
- 5. I declare that the alterations particularised in the **Annexure 'A'** were to the best of my knowledge made in accordance with the Rules of the Northern Mining and NSW Energy District Branch of the MEU, in particular Rules 8 and 14. The actions taken under the Rules to make this alteration included the following:
 - (a) On 6 August 2025, in accordance with Rule 14(b), I caused a draft proposed rule change to be sent by email to the Northern Mining and NSW Energy District Rules Committee (Committee) for discussion, and for the Committee to provide a report to the Northern Mining and NSW Energy District Board of Management (BOM).
 - (b) On 1 July 2025, and in accordance with Rule 8(ii) and Rule 14 of the Northern Mining and NSW Energy District Rules, I caused the BOM members to be notified by email of a BOM meeting to convene on 13 August 2025. A draft agenda, a copy of the proposed rule change to allow for the introduction of Vice-President (E), along with a copy of the report of the Rules Committee was provided. A copy of the proposed rule change sent to the BOM is attached and marked Annexure 'A'.

(c) On 13 August 2025, and in accordance with Rule 8(ii)(b) and Rule 14 of the Northern

Mining and NSW Energy District Rules, a quorum of the BOM unanimously

endorsed the proposed Rule change of the Northern Mining and NSW Energy

District to allow for the introduction of the position of Vice-President (E), at the

discretion of the Board of Management. A copy of the resolution is attached and

marked Annexure 'B'.

6. On behalf of the Northern Mining and NSW Energy District Branch of the MEU, I provide

consent for the correcting of any other typographical, clerical or formal errors

associated with this application, provided that the errors are first notified to the District

Branch for comment. I confirm that I am authorised to give the aforementioned consent

under section 159(2) of the Fair Work (Registered Organisations) Act 2009.

7. I have requested that the Northern Mining & NSW Energy District Branch post on its

website a notification in relation to the rule changes the subject of this notice and

declaration as soon as practicable following the lodgement of the notice.

8. I declare that the particulars set out in this notice are true and correct to the best of my

knowledge and belief.
